Who am I? I rent a home in Glassell Park. I am a small business owner (furniture restoration) and my husband is an editor. We are both college educated, paying off student loans and hoping to start a family. Unfortunately, both of us have had to stop working as we cannot simply work from home (example: there's nothing to edit when shoots are cancelled). It has been made public that the majority, 8 of the 15, council members are landlords (if not more). After the reading about the L.A.'s city council actions on March 17th, I believe it is clear we have a conflict of interest at work. I believe that the majority of city council is not working for the best interest of this city's citizens and is acting out of self interest, as landlords, and thus are creating legislature that would insure all of their rent money be paid up in full within the next 6 months. Most of their tenants, as well as other regular home owners paying mortgages, will NEVER see the money they have lost due to the pandemic. It's gone. Yet somehow landlords would like their well being prioritized above all others. This is wrong. Landlords are regular citizens too, regardless of whether they are mom and pop or are huge real estate corps... they cannot and should not be given special treatment. We must shoulder the burden fairly and we must do it together. It is painful to read that the 24 month repayment period suggested by Council member Bonin was knocked down to 6 months. Again, the residents that are losing their income through March, April, and so on... are NOT going to get their lost money back. Where does city council think this payback money for landlords is going to come from? Rents in Los Angeles are high, the federal payouts will likely only cover a fraction of LA residents' costs. Expect that people are going to go deeper into debt. Even as someone that has savings, I'm accepting that I'm going to lose a lot of it to get through this... but I'm going to bear it because I know we're all in this together. That said, I can't imagine how most low wage employees are going to be able to backpay rent for three months in a matter of six. I appreciate city council's optimism but that's foolishly blind. Ultimately, regardless of whether it is 6 months or 24 months, it's not about

time, it's about sharing in loss as we share in civic prosperity... we must all work together to absorb this burden. I'm not arguing for a full rent freeze but if the city council wants to make sure landlords are going to get ALL their money while other renters and home owners are losing it hand over fist... then maybe our landlord run city council should be more transparent about their goals. Why not have council members use public funds to pay it to themselves and their fellow landlords, instead of hiding behind unfair legislation, let's see how that flies.
