On behalf of myself and my employees, we urge you to consider the needs of restaurants and the hospitality industry. Many of us are small businesses who will be irrevocably harmed during this unstable time. In the past few days, every restaurant and bar in the City has been forced to close or pivot to accommodate delivery-only and takeout. For many restaurants, it is unfeasible to make this adjustment. While we understand that this is for the good of our community, it has had a detrimental effect on our business and our employees. I know that the City Council has the best interest of our restaurants and our employees at heart. We fully support Motions 72N, 72R, 72Z and 72QQ. These motions will truly help revive the hospitality industry after we come out of this public health crisis and allow us to take care of our employees during this extremely difficult time. Our employees are family to us. Since the mandated shut-down, we have done everything possible to take care of them for as long as this may last and work to make sure they have a job to come back to when we are able to re-open. However, I worry that some of the proposed motions will end up hurting our employees more than they would help them. Please Oppose Motions 72J and 72KK. Both motions will make it harder to bring our employees back as soon as possible.
