Salyer-Park Ranger gunned down when checking a campsite -Danny Blumenthal-Park Ranger gunned down while doing maintenance and checking a restroom with another Ranger These are just a few examples of Park Rangers killed by gunfire on duty while performing tasks or making contacts that might be considered "routine, low risk" by people that have no law enforcement background or training. This doesn't even list murders of Rangers (or even Rangers that survived attacks) by methods other than gunfire or Rangers killed when responding to calls where there was a known or suspected weapon. Remember that the initial context for a stop or dispatched call doesn't determine the outcome of the call, much less the mindset or motivation of a contacted person. There is no law enforcement "lite." Even when not performing a "law enforcement" duty, Rangers are still law enforcement officers, and thus a target. The mere presence of a firearm on an officer's belt can deter or prevent violent altercations and assaults on officers and promote general compliance. This is in addition to the obvious necessity of having a firearm to overcome a deadly threat. LA City Park Rangers are trained to POST standards and attend a standard law enforcement academy. Firearms are one part of the necessary, standard tool kit used by other effective, trained law enforcement officers (CHP, local police, sheriff's deputies, game wardens, arson investigators, etc.). The mere title of a law enforcement officer shouldn't change the tools available to them when time-tested evidence across the nation and around the globe has demonstrated what is needed to do the job. Why should Rangers be expected to do their jobs with less than the basic tools of any other officers that are trained the same and face the same circumstances? They shouldn't. Please provide the appropriate tools to Rangers so that they can do their jobs safely and effectively while providing maximum service to the public.
