Putting a gun into any situation raises the stakes, with the worst outcome being unjustified murders of civilians. Our park rangers already have access to effective less-than-lethal uses of force and extensive training to control a situation if it gets out of hand. They also work closely with the LAPD. Instead of arming park rangers, the city should invest in further training and updating current equipment. Once again, I am AGAINST the motion to amend LAMC Section 63.41 (Council File Number 20-0190).

I have visited the park during night and day, from the peaks to the observatory to the river trails, and have never felt threatened in it, including by anyone currently experiencing homelessness. I don't know what training courses these rangers have already had, but perhaps additional de-escalation training could help them safely defuse tense situations without use of force.

**Comments for Public Posting:** Since its founding in 1896, Griffith Park has always been a "safety valve" for the city of Los Angeles. A place where all Angelenos can enjoy access to nature and rare public space without paying an entry fee. Its founder and donator Griffith J. Griffith knew that major public parks were not a luxury, but a necessity for large cities. Almost 125 years later, Los Angeles is still striving for Griffith's vision, and it goes without saying that the park now attracts an audience that is significantly more diverse than it did in his time. In 2020, touting "more firearms" and "LAPD training" does not necessarily lead to visions of increased security or safety, especially for people of color and other minorities. LAPD-training does not have a sterling track record of treating all Angelenos equally even today, and indeed LAPD actions inside the park have historically escalated conflict, not reduced it. In 1961, a racially tinged dispute at the Merry-Go-Round erupted into a full blown park closure, with over 60 officers closing down the park for days. In the 70s and 80s, persecution of LGBT individuals was so harsh that volunteer citizen squads were formed to police the policing. Public interactions and expectations of park rangers are significantly different than those with uniformed police officers and the two should remain separate and distinct entities. The park needs more rangers, and those rangers need to be on the trails -- offering help and assistance, interpretation and guidance, and enforcement of park rules. And I don't think they need to be armed to do any of that. At the very least, I urge the Council to reconsider this motion and do more outreach to additional neighborhood, citizen, and outdoor groups for input. Three statements from neighborhood councils is simply not enough input to change a policy for a park that sees more than 10 million visitors a year. If the park rangers are losing ranks due to increased violence, we need to see that data. If the rangers cannot call on LAPD for the rare instances when they need to be armed, why can't they? And if they can, why do they need to be armed?
