At its regularly scheduled public meeting on June 8, 2020, the NoHo Neighborhood Council voted 20 [YEA] to 0 [NAY] with no abstentions in favor of Council File 20-0215, which requests additional funding in Council District 2 for a Multi-Disciplinary Team ("MDT") to provide assistance and specialized services for persons experiencing homelessness, such as mental health assistance, referrals for substance abuse support and treatment, case management, and connections to housing authorities.

In the wake of COVID-19, our neighbors living on the street without a home are increasingly vulnerable. Municipal services have reduced hours, public spaces such as parks and libraries are closed, and food banks are stretched to their limits. An economic downturn is set to reduce our city's capacity to provide for and protect our most at-risk residents.

We urge the Los Angeles City Council to support the allocation of \$450,000 of the State's Homeless, Housing, Assistance and Prevention program grant fund for outreach services in Council District 2 as soon as possible.
