**Comments for Public Posting:** Tenants are the most vulnerable members of the Los Angeles community and also the majority of its citizens. It is simply unthinkable that the city would double down on the financial pain of the COVID-19 crisis by giving these people — the foundation of the city's community and economy — only a year to repay or risk being out on the street. No matter what they say, most landlords will not face literal homelessness if their renters are not made to pay, and they have access to relief that renters currently do not, especially given the repeated failure of the federal government to pass meaningful stimulus payments. There can be no reassurance that the millions out of work in our city will be able to have made up that payment in an economy still rocked by COVID-19. A massive wave of evictions will likely follow upon the conclusion of that year, worsening homelessness and gentrification and giving landlords the opportunity to jack up rents on newly vacated units. Landlords would in that case almost certainly use the crisis as a way to make Los Angeles even less affordable for working people. We cannot allow our neighborhoods and our communities to be eviscerated by greed right when we are all already hurting so much. It is the urgent duty of the City Council — especially the many landlords on the City Council — to protect Angelenos and set a different, better course than that which housing issues usually take in Los Angeles. There is a high moral duty to be met: the business interests of developers and property owners are not and should not be of a higher priority as shelter and safety for the people of our city. Two years for repayment, or a total rent moratorium would be an excellent step.

After months of work and our last dollars spent on renovations, this is a particularly miserable time – we had our venue booked out for 8 months of gigs that now can not take place. Less than half of people still have a job in LA (LA Times, April 17, 2020) and we need the council to act now to ban all evictions in the city: residential and commercial alike. It is also important that the latter, commercial leases, are not ignored in this fight for survival. Forgiveness should be included in this conversation, but keeping a roof over our business' head and somewhere to store all of our equipment that we pulled from our storage facility is crucial. The alternative will create a public health crisis and hobble any chance of economic recovery once the pandemic has passed. In truth we need more: rent cancelation and Federal relief funds for property owners who will lose revenue in this time, but a proper prohibition on all evictions, lockouts, and utility shutoffs is a necessary first step.
