COMMUNITY IMPACT STATEMENT / CF 20-0496: COVID-19/Restaurant Relief Program

Dear Council Members:

We declare that on May 12, 2020 a Brown Act noticed public meeting was held by the Eagle Rock Neighborhood Council (ERNC) at which a quorum was present. The following motion concerning Council File 20-0496 passed unanimously:

The Eagle Rock Neighborhood Council supports this Motion to develop a restaurant relief program that would allow local independent restaurants to temporarily contract with the City of Los Angeles to provide meals to our most vulnerable populations.

The Motion would further instruct the City's Economic and Workforce Development Department, with the assistance of the Chief Legislative Analyst and City Administrative Officer, to develop a restaurant relief program that would allow local independent restaurants to temporarily contract with the City of Los Angeles to provide meals to residents experiencing homelessness located at emergency shelters, seniors who were previously receiving congregate meals at city dining centers and/or home delivered meals, students who received meals or supplemental nutrition as part of a city sponsored after-school program, the City of Los Angeles' first-responders, and City employees that are temporarily serving in a Disaster Service Worker capacity, amongst others, as necessary, and transmit the proposed program for Council consideration.
