RE: Our opposition to Budget Scale-back of Wildlife Pilot Study (CF 20-0600)

Honorable Council President Nury Martinez and Members:

The challenges of balancing the City budget during these unprecedented COVID times require tough choices. Friends of Griffith Park believes that removing funding for the Los Angeles Wildlife Pilot Study would be a groundless error in judgement and a decision not easily forgiven by Los Angelenos who wholehearted supported the pilot study.

As clearly stated in the memo to the Budget and Finance Committee one year ago, May 7, 2019 "... this proposal is viewed as a priority for the City," per Director of Planning, Vincent Bertoni. Today, even under severe financial hardship, it remains a priority.

There is little doubt that the health of our ecosystems and vitality of our biodiversity are major factors and driving forces toward economic prosperity. While P-22 is an icon around which citizens have rallied for wildlife, it is also well recognized that the City is far behind other jurisdictions in regulation and incentives to create sustainability of natural resources that bless us. The City is already playing "catch up."

For example:

- Ridgeline development remains unregulated in the City's hillsides, while the County has been protecting them for over a decade and a half.
- Fencing is regulated by height only, not by permeability. Worse, razor and barbed fencing is allowed even in hillside residential up to eight feet, while planning code in many other cities reflects its hazards to wildlife.
- Lighting disturbances that affect wildlife are unregulated, and there is little leadership by City departments toward their own best practices.

- Stronger measures for the City's Protected Tree Ordinance are sorely needed. Wider protection and mitigation measures are apparent in the planning code of surrounding municipalities, while motions to strengthen City native tree protection remain in limbo.
- Even the most potent of the anticoagulant rodenticides are not only unregulated in the City, but they are still being used within our city parks. Hopefully, the State will close this gap for us by acting on AB 1788 in 2020.
- Most importantly, accommodations for wildlife connectivity through thoughtful and enlightened concepts, some which can be applied with little or no marginal costs by developers, are non-existent in our planning code. The City ranks fairly low (level 2 of 4) when applying the "effective mesh size" measure for connectivity, part of the Singapore Index, as reported in the Department of Sanitation 2018 Biodiversity Report.

As of last week, the mountain lions of the Santa Monica Mountains, along with other subpopulations, are now candidates for listing under the California Endangered Species Act. As such, they are currently afforded the same full protection as permanently listed species. Now is an opportune time for the City to show leadership and responsibility, giving this majestic species a fighting chance against an extinction vortex occurrence.

Friends of Griffith Park maintains that the City cannot afford to abandon the Wildlife Pilot Study, especially since the team is only months away from having a draft ordinance. We encourage you to pull no funds away from this initiative which will pay back the City in so many ways.

Honorable Mayor Garcetti:

I am writing to urge you not to defund the Wildlife Corridors Project and the Wildlife Pilot Study within it. To do so would jeopardize protections for wildlife in the Santa Monica Mountains, which are an essential and unique feature of our City of Angels and provide many opportunities for Los Angeles residents and visitors to learn from and appreciate nature.

You were correct when you recently said that "There is literally no time to waste – because what we do in the next ten years will determine the health of our planet..." Millennia of evolution have endowed our local mountains with unique and irreplaceable flora and fauna. To allow destruction of the Wildlife Corridors Project now after the progress that has been made in understanding the interactions that sustain this mountain wildlife treasure in our city would be a terrible mistake. The Wildlife Corridors Project was funded in 2018 and is close to a draft ordinance. Rather than waste the efforts and data already collected, we urge you to continue this landmark project and restore funding even during this difficult time of budget restraints.

Since Councilmember (CM) Koretz's original motion in 2014, we have seen great support for preserving connectivity and biodiversity in Los Angeles. The Bel Air-Beverly Crest Neighborhood Council (BABCNC) has closely followed and strongly supported the creation and progress of this project since its inception. Bel Air Beverly Crest Neighborhood Council supports Councilman Koretz's wildlife connectivity motion for the investigation into and creation of Wildlife Corridors as they relate to new construction and development, to preserve the wildlife corridors, and requests to be consulted by the City Attorney and Planning Department in the development of said ordinance should the motion be passed by the City Council.

### Details of the Motion:

WHEREAS, the Bel Air-Beverly Crest Neighborhood Council territory includes natural lands and low-density residential neighborhoods that allow wildlife movement in the Eastern Santa Monica Mountains, and

WHEREAS, the process of land development in the BABCNC territory often involves actions that might affect wildlife movement, and

WHEREAS, viewing and enjoying wildlife is a unique experience characteristic of the quality of life in the BABCNC territory, and

WHEREAS, Councilmember Paul Koretz has introduced a motion (Council File 14-0518) to establish a process to develop and ordinance that would clearly delineate the responsibility of potential land developers to map maintain wildlife connectivity on properties to be developed to ensure that wildlife such as deer and bobcats can range through the eastern Santa Monica Mountains, and

WHEREAS, said motion was seconded by four City Councilmembers representing broad support across the City, and

WHEREAS, the Santa Monica Mountains Conservancy has begun to undertake the development of wildlife corridor maps within its territory and already currently advocates for measures similar to those being proposed by Councilmember Koretz,

WHEREAS, both private property interests and environmental considerations benefit by definite and consistent guidance on the environmental constraints and considerations in real estate development,
