On behalf of the National Wildlife Federation, I urge you to retain the funding for the Wildlife Pilot Study in the Fiscal Year 2020-21 Budget Proposal. The Federation is one of the oldest and largest wildlife conservation groups in the country, with 6 million supporters nationwide. Our organization provides a voice for wildlife, and is dedicated to protecting wildlife and habitat, and inspiring future generations of conservationists.

In California, the Federation works on a number of conservation projects, and our work throughout the state focuses on restoring habitat, connectivity and corridors for wildlife. We are also one of the primary partners in building the wildlife crossing at Liberty Canyon, which will restore a key linkage for wildlife in the area and help save the local population of mountain lions from extinction. The City of Los Angeles area is an important part of this linkage.

Improving connectivity is key to ensuring a future for these cats, and all wildlife in the Los Angeles area. The situation is so dire for the area mountain lion population that the California Fish & Game Commission recently voted unanimously to consider further protections under the state's endangered species act.

We understand these are challenging times, and human health and safety must be a priority. Yet healthy ecosystems are also critical to human health. TreePeople believes that a healthy urban forest is essential infrastructure to a thriving, sustainable, and resilient city. Los Angeles's urban forest, if planned and managed well, can protect Angelenos from many of the current and future impacts of climate change including saving lives from extreme heat, capturing and cleaning water, improving human health and wellbeing, and providing many other life-supporting benefits.

Given the sobering reality of Mayor Garcetti's proposed budget and the Newsom Administration's recent projected \$54 billion budget deficit in California for FY 2020-21, this letter puts forward two critical requests that would ensure the City's significant progress in urban forestry is not lost this budget cycle.

To better align with the Mayor's priorities expressed in the Green New Deal and to better serve Angelenos, especially during this difficult time, we respectfully request these two items be given strong consideration:

 Funding to maintain the current urban forestry staff level and provide support staff for the City Forest Officer without any additional personnel changes. This includes funding to support the proposed new positions for the City Forest Officer in the Board of Public Works. We also strongly oppose the Mayor's proposed elimination of the 7 vacant positions in the **Urban Forestry Division of the Bureau of Street Service.** It is critical to strategically support the urban forestry workforce in the City to sustain LA's urban forest and the desired benefits for current and future generations.

• \$400,000 or more for a complete Urban Forestry Management Plan. With the first-ever City Forest Officer and the ongoing street tree inventory, we believe it is past time to develop an urban forestry management plan that serves as a roadmap for urban forestry management in the City.

However, it will be a tragic mistake to place at risk the disastrous environmental impact to our wildlife and native habitat, wildlife corridors, and passive recreational trails, by cutting funding of LA's Wildlife Pilot Study. The Federal Rim of the Valley Preservation Act (ROV) passed the Congressional House in February, 2020, an overlay of the Wildlife Corridor Ordinance, with future opportunity to co-support our wildlife corridors/native plants-trees/biodiversity/trails for both humans and wildlife in our region.
