Request for Additional Funds to hire more staff at LA Animal Services Shelters

To: The Budget and Finance Committee of the LA City Council:

We are the volunteers at all 7 of the LA Animal Services Shelters. We are very concerned about the lack of enough paid personnel in the shelters, and are urging you to please provide funds for 45 new positions for Animal Care Technicians.

We are noticing every day the difficulty of providing basic care for the animals. Sometimes dogs are without clean cages, they aren't walked for days, cats and bunnies are not well-cared for, and people who come to the shelters to adopt cannot find an employee to help them. We know that during the last recession, 100 people were let go. Since then, all our shelters have many more animals and we've even added a new shelter!

There is no way for the paid personnel to keep on top of all the demands, and we volunteers take up a lot of the slack, but it is a worsening situation and we see the misery of the animals. There are behavior problems due to lack of socializing or getting out of their cages, there are injuries and bites due to the behaviors, and then liability payouts for the City. It isn't possible to have deep cleaning and sanitizing of the cages, clean bedding, practices that will decrease the length of stay, animal enrichment programs or positive adoption outcomes with a limited staff.

Often, a shelter is run with only 3 Animal Care Technicians per day, which is not in any way sufficient for the number of animals and the size of our shelters.

Please consider that we are the 2nd largest city in the country, and we deserve to be doing a better job for our voiceless and vulnerable furry friends.
