


**Comments for Public Posting:** Hello City Council, I am writing you all today to ask you to divest more of the budget from the LAPD into social services like Housing & Community Investment, Emergency Management, Cultural Affairs, Transportation and Rec & Parks. The proposed 100-150 million cut is a good start but that still leaves the LAPD with upwards of \$3 billion, a massive majority of the budget. That must change. So much has happened over the past week that has illuminated the contradictions between our law enforcement and our city. I've seen peaceful protests met with a hulking and brutal response from the LAPD. I've seen Michel Moore blame the death of George Floyd on protesters instead of the police that shoved their knee into Floyd's neck for 9 minutes cutting the blood circulation into his head and killing him. I've also seen the video circulating of the LAPD voice dissatisfaction with Council member Monica Rodriguez saying that they are the ones keeping the city from being on fire and that they have over time been forced into adopting many jobs and services outside of their primary job of policing, i.e. becoming social workers because people will call 911 expecting that to solve all problems. It is true that it is ridiculous to expect the LAPD to be social workers -- that is why I hope City Council considers divesting more of the budget from the LAPD and apply it toward social services that are appropriate for aiding and assisting those in need rather than calling the police. The taxpayer money invested into our city should reflect the one that we want for our futures. These past two weeks of protest have been extremely educational I hope that you all have seen and reflected on these past two weeks of protest and that those reflections show up in real concrete ways into our future, one that is hopefully less dependent on the LAPD and more reliant upon the people who live here. In that video of LAPD speaking with Council Member Rodriguez, the LAPD officers end with the threat that since these cuts will take "from their families and they put everyone on the line? We are going to fight at the ballot box." I can't stop thinking about how the contradictions that a statement like this makes. The LAPD are given state of the art riot gear while our health care professionals have to wear trash bags. The Police say that these cuts will take away from their families but what about Ryan Twyman's family? Or Kenneth Ross Jr.'s family? Or Kenney Watkins' family? What

about the families who have had their sons, daughters, husbands, wives, loved ones taken away from them unjustly by the police? That video of the LAPD confronting the Council Member Rodriguez underlined and bolden the contradiction within the LAPD and their inability to hold themselves accountable. Do the right thing and cut that LAPD budget and fund the services that make a positive difference in people's lives rather than unjustly taking it away. Thank you for your time, Brian Smee (P.S. 


### **Top Priorities for Investment**







Dear Council President Martinez and Councilmembers.

We believe that a healthy urban forest is essential infrastructure to a thriving, sustainable, and resilient city. Los Angeles's urban forest, if planned and managed well, can protect Angelenos from many of the current and future impacts of climate change including saving lives from extreme heat, capturing and cleaning water, improving human health and wellbeing, and providing many other life-supporting benefits.

While we recognize the unprecedented budgetary challenges due to the pandemic that may be exacerbated by the daily protests permeating the City, it is important to protect and expand on the critical urban forestry gains that the City has made. Alternatively, all of the progress achieved over recent years could be wiped out in just one budget cycle -- an unacceptable and destructive outcome that should be avoided. To align with the Green New Deal and to better serve Angelenos, especially during this difficult time, we strongly support and urge you to join in supporting the following urban forestry related motions:

• Motion Number: 12 (B20F 013-MSR): Presented by Councilmember Blumenfield, 3rd District "I MOVE that the Mayor's Proposed Budget for 2020-21 be amended to exempt the Bureau of Street Services from the hiring freeze, so long as hiring stays within budgeted levels, and authorized the use of grant funds to offset furlough days, in order to help ensure that projects do not experience delays."  Motion Number: 14 (B20F 016-VD): Presented by Councilmember Koretz, 5th District

"I MOVE that the Mayor's Proposed Budget for 2020-21 be amended to add resolution authority without funding in the Board of Public Works for one Management Analyst position for their Grants Unit."

 Motion Number: 28 (B20F 026-JWD): Presented by Councilmember Blumenfield, 3rd District

"I MOVE that the Mayor's Proposed Budget for 2020-21 be amended to add resolution authority and 9 months funding for seven positions in the Urban Forestry Division of the Bureau of Street Services consisting of two Tree Surgeon Supervisor I's, three Tree Surgeon Assistants and two Equipment Operators, add resolution authority and 9 months funding for one Management Analyst position in the Board of Public Works to lead a Grants Unit focused on seeking funds to implement various community beautification and tree management initiatives, provide \$400,000 in the Board of Public Works to continue the development of the Urban Forest Management Plan, and, to instruct the City Administrative Officer to identify additional options to avoid cuts to the Urban Forestry Division."

Thank you for your leadership and support for Los Angeles's urban forest. We look forward to working with you on this critical issue to achieve a greener, healthier, and more climate-resilient future for all Angelenos.
