## BUREAU OF ENGINEERING FISCAL YEAR (FY) 2020-21 PROPOSED BUDGET (C.F. 20-0600)

The Bureau of Engineering (ENGINEERING) recognizes the unprecedented impact of the coronavirus and the magnitude of the resulting budget challenges. We are committed to delivering our services to the full extent of the resources provided to us.

The FY 2020-21 Proposed Budget includes various reductions to salary funding. Key elements are as follows:

- 26 furlough days for all staff and an accompanying 10 percent salary reduction,
- \$2.0M in additional General Fund (GF) salary reductions, and
- General Fund salaries are about 80% funded in total.

The proposed reductions, coupled with the implementation of the hiring freeze, will impact ENGINEERING's ability to deliver our core services of capital project delivery, development services and mapping. We will be initiating a review of our capital projects and work programs to make necessary adjustments to reflect the available staffing level. For development services to the public, LADWP, LAWA and Metro, planning will be more challenging due to the uncertainty of permit application levels. We will adjust staff assignments and resources to provide services in the most efficient manner, however it is possible that a backlog will develop.
