Thank you for your work on the budget and finance committee. I am writing to you as a citizen from the 10th district and I have several concerns about the current budget proposal.

#### 1. Performance Measurement

The current measures of performance of the city's goals lack an ability to truly see if the outcomes we are seeking are those that are being delivered. The current measures are numbers focused and do not provide any picture of how citizens feel about living here, or other relevant information on the services being provided. These measures should be revisited and funding should be directed towards reaching these measures.

#### 2. Police Funding

Police brutality is horrendous. It is time to rethink this system and program. I understand that there will be furloughs to the civilian employees in the LAPD but all other funding has remained the same. There is a need to look at the outcomes for performance measurement that are being sought through the police department (e.g. number of crimes and the percentage of internal affairs cases closed). These measures do not address how many internal affairs cases were opened, what the police are doing to engage the community, or any sort of participation in bias training. It is imperative that we redesign the way the police are interacting with and serving their community. There must be new and improved outcomes that are discussed between the citizens, city council, and police. There should be an increase in funding for programs and services that will help people and the current model is not working.

I hope this committee takes time to truly examine these documents and fight for what it is your citizens are asking for.
