**FIRST AMENDMENT TO
CONTRACT NUMBER C-115759
BETWEEN
THE CITY OF LOS ANGELES
AND
GETTY HOUSE FOUNDATION**

FIRST AMENDMENT to Contract Number C-115759, between the City of Los Angeles, a municipal corporation (hereinafter referred to as the "CITY"), acting through the Department of General Services (hereinafter referred to as the "Department") and Getty House Foundation (hereinafter referred to as "CONTRACTOR"), is entered into with reference to the following:

WHEREAS, on or about July 20, 2009, the CITY executed Contract No C-115759 wherein CONTRACTOR provides oversight, management and maintenance of all activities of the Getty House which is a CITY owned facility and serves a public purpose.

WHEREAS, the CITY now desires to amend the Contract to extend the period of performance as needed and to provide the supplemental funding therefor.

WHEREAS, This amendment is necessary and proper to continue or complete certain activities authorized under the Contract.

NOW THEREFORE, The CITY and the CONTRACTOR agree that the Contract be amended effective July 1, 2010 as follows:

Paragraph "A" appearing on Page #1 of the Agreement is hereby deleted and replaced with: "The CITY's Budget (Department of General Services Fund) for the fiscal year ending June 30, 2010, includes an appropriation *that is sufficient to extend this agreement for one (1) additional year through June 30, 2011 at the same annual funding level as in the original Agreement (\$118,000 ANNUALLY) to continue to partially fund the CONTRACTOR's activities for the additional time period. The CONTRACTOR understands that said funds will be disbursed to it only in accordance with the original Agreement as amended herein.*

Paragraph "1." entitled TERM OF AGREEMENT is hereby amended to extend the time period of performance for one (1) additional year to June 30, 2011 and to provide an additional one hundred eighteen thousand dollars (\$118,000) for the performance thereof.

All references in the AGREEMENT to the date "August 16, 2010" are herein amended to state "August 16, 2010 and/or August 16, 2011" whichever is appropriate".

ALL OTHER PROVISIONS OF THE CONTRACT REMAIN UNCHANGED
