FIFTH AMENDMENT TO
CONTRACT NUMBER C-115759

THIS FIFTH AMENDMENT to Contract Number C-115759, between the City of Los Angeles, a municipal corporation (referred to in this agreement as the "CITY"), acting through its Department of General Services, and Getty House Foundation (referred to in this agreement as the "FOUNDATION"), is entered into with reference to the following.

WHEREAS, on or about July 20, 2009, the CITY executed Contract No. C-115759 wherein the FOUNDATION provides oversight, management, and maintenance of all activities of the Getty House, which is a CITY-owned facility and serves a public purpose;

WHEREAS, on or about April 24, 2013, the CITY and the FOUNDATION executed the Fourth Amendment to Contract No. C-115759 to extend the term of the Contract through the current fiscal year, which ends June 30, 2014;

WHEREAS, pursuant to the Fourth Amendment, the CITY partially funded the FOUNDATION's activities with a renewed annual appropriation of one hundred eighteen thousand dollars (\$118,000);

WHEREAS Mayor Eric Garcetti has established a goal of bringing long-term sustainability to the CITY's finances to make the CITY more prosperous, more well-run, safer, and more livable by rebuilding vital services and investing in the CITY's future;

WHEREAS, as the economy recovers, the CITY continues to face significant budgetary challenges at the same time that the FOUNDATION is better able to sustain itself; and

WHEREAS the FOUNDATION wishes to do what it can to support Mayor Garcetti's goal of fiscal sustainability for the CITY;


NOW THEREFORE the CITY and the FOUNDATION agree that the Contract be amended as follows.

1. The Fourth Amendment to Contract No. C-115759 is hereby repealed.

2. Not later than June 30, 2014, the FOUNDATION shall return to the CITY its current annual appropriation of one hundred eighteen thousand dollars (\$118,000).
3. In all other respects, the Contract (including Paragraph 5) is deemed retroactively terminated as of June 30, 2013.

IN WITNESS WHEREOF, the parties have caused the Fifth Amendment to be signed by their authorized representatives.
