

ORDINANCE NO. 183492

An Ordinance of the City of Los Angeles declaring the intention of the City Council to order the vacation of:

1. New High Street from approximately 160 feet southwesterly of Spring Street to Arcadia Street.
2. Republic Street from New High Street to North Main Street.
3. A portion of the northeasterly side of Arcadia Street at the southwesterly terminus of New High Street, to proceed under Chapter 3 of the Public Streets, Highways and Service Easements Vacation Law, and that any easements needed for the protection of drainage, sanitary sewer and public utility facilities be allowed to be reserved in the Resolution to Vacate.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Los Angeles hereby declares its intention to order the vacation of:

1. New High Street from approximately 160 feet southwesterly of Spring Street to Arcadia Street.
2. Republic Street from New High Street to North Main Street.
3. A portion of the northeasterly side of Arcadia Street at the southwesterly terminus of New High Street,

and allowing the reservation of any needed easements in the Resolution to Vacate for the protection of drainage, sanitary sewer and public utility facilities pursuant to Chapter 5 of said Vacation Law.

For further particulars as to the proposed vacation, reference is hereby made to the map as Map No. VAC-11-1400777 on file in the office of the City Engineer, 201 N. Figueroa Street, Suite 200, Los Angeles, California.


Sec. 2. The hour of 10:00 a.m. of the 27th day of MAY, 2015, in the Council Chamber in the City Hall, Los Angeles, California, be and the same are hereby fixed as the time and place when and where all persons interested in or objecting to the proposed vacation may appear before the City Council and offer evidence in relation thereto.

Sec. 3. The Bureau of Engineering of the City of Los Angeles is hereby directed to cause Notices of Street Vacation to be posted as required by the "Public Streets, Highways and Service Easements Vacation Law" of the California Streets and Highways Code, and the City Council hereby elects to proceed under the provisions of said Law.


Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


