On March 5, 2002, under Council File No. 01-1459, the City Council adopted new procedures for processing street vacations, which require the adoption of a Rule 16 motion to initiate street vacation proceedings. Under these new procedures, when a petitioner submits an application and a fee deposit to the Bureau of Engineering, the Chair of the Public Works Committee is required to introduce a motion for the purpose of initiating the investigation of the vacation.

The City Council on October 18, 2006, under Council File No. 06-2469, conditionally approved the vacation of L-shaped alley southerly of 108th Street and easterly of Clovis Avenue. The vacation conditions were not complied with prior to the expiration of the vacation approval.

The Los Angeles Unified School District, owner of the property legally described as Arbs 2 and 6, Pt of Lot A, Lots 15 through 39, and Lots 48 through 57 of Tr No.6478, and Arbs 1 and 2, Pt of Lt 3 of S/W ¼ of Sec 4 T3S R13W, has submitted a new application requesting to vacate the same street, located in Council District 15.

Additionally, the adoption of the following recommendations does not constitute or imply approval of the vacation.

I THEREFORE MOVE that upon adoption of this motion, street vacation proceedings to vacate the L-shaped alley southerly of 108th Street and easterly of Clovis Avenue, be initiated pursuant to California Streets and Highways Code, Division 9, Part 3, Public Streets, Highways and Service Easements Vacation Law.


I FURTHER MOVE that the Bureau of Engineering be directed to process this vacation request under Council File No. 06-2469, Engineering work order No. E1401013, and apply the conditions established under the Council action of June 15, 2007, under Council File No. 06-2469 to this vacation request.

I FURTHER MOVE that the Bureau of Engineering present its report regarding the feasibility of vacating the requested area to the Public Works Committee.


