# MOTION

Item No. 4 on today's Council Calendar Agenda is consideration of a community naming application to expand the boundaries of Lake Balboa (CF: 06-2613), located in Council Districts 6 and 12. On April 23, 2007, the Education and Neighborhoods Committee held a hearing on this item. Upon the initial review of the application the status of the original Lake Balboa community designation was uncertain, and a significant number of stakeholders voiced opposition to the application.

As a corrective measure, the Council on October 5, 2007 adopted the Motion (Smith-Zine) relative to the naming of the southwestern part of Van Nuys as "Lake Balboa" (CF: 06-2613 S1). This action confirmed some previous administrative steps taken by the Department of Transportation in 2002 to post Lake Balboa community signs.

Subsequent to the posting actions taken in 2002, the City Council adopted formal procedures for the establishment of community names. The submission of a naming application for consideration is part of the application process. The affected Council Offices (CDs 6 and 12) have met with stakeholders in their respective Council Districts and have identified proposed new boundaries for the Lake Balboa community (see Attachment A).

I THEREFORE MOVE that relative to CONSIDERATION of the community naming application for Lake Balboa, Item No. 4 on today's Council Agenda (CF: 06-2613), BE AMENDED to substitute the attached new Lake Balboa community boundaries in lieu of the boundary changes proposed in the naming application attached to the Council File, and that the amended Lake Balboa community naming application BE ADOPTED.

## Lake Balboa Name Change Boundaries

- 1.) Bound on the East by the 405 Freeway from the where it meets the 101 Freeway go North to Saticoy Street.
- 2.) At Saticoy Street, go west to Valjean Avenue until you reach Vanowen Street.
- 3.) At Vanowen Street, head West to Havenhurst Avenue.
- 4.) At Havenhurst Avenue, head North once again to Saticoy Street.
- 5.) At Havenhurst Avenue, head West on Saticoy Street once again.
- 6.) At Balboa Boulevard, head North to Balboa Place and then continue North to Roscoe Boulevard.
- 7.) At Roscoe Boulevard, head West to Louise Avenue. (South side of Roscoe Blvd, from Balboa Boulevard to Louise Avenue will remain Northridge with the 91325 zip code).
- 8.) At Louise Avenue, head South to Saticoy Street. (East side of Louise Avenue, from Roscoe Boulevard to Stagg Street will remain Northridge with the 91325 zip code).
- 9.) At Saticoy Street, head West to White Oak Avenue.
- 10.) At Whiteoak Avenue, head South to Victory Boulevard
- 11.) At Victory Boulevard, head East to Balboa Boulevard.
- 12.) At Balboa Boulevard, head South to the Los Angeles River
- 13.) Follow the Los Angeles River, going Southeast, to where the 101 and 405 Freeway meet.
