Fiscal Impact Statement: The City Clerk reports that there is no impact to the General Fund associated with the action as detailed above in Recommendation Nos. 1 and 2.



SUMMARY

On September 1, 2009, the Chair of the Jobs and Business Development Committee considered an August 7, 2009 Annual Planning Report for the Highland Park BID's 2009 fiscal year. According to the City Clerk, the Highland Park Business Improvement District was established on September 21, 2001 by and through the City Council's adoption of Ordinance No. 174,251, which confirmed the assessments to be levied upon properties within the District, as described in the District's Management District Plan. The City Council established the District pursuant to the LSPM PBID Ordinance. Next, the City Clerk then provided an overview of the Highland Park BID's organization, activities, and funding.

After consideration and having provided an opportunity for public comment, the Committee Chair moved to recommend approval of the recommendations as contained in the August 7, 2009 report and detailed above in Recommendation Nos. 1 and 2. This matter is now submitted to Council for its consideration.
