**MOTION**

I HEREBY MOVE that Council ADOPT the following recommendations of the City Attorney relative to prohibiting the harassment of bicyclists (Item No. 19, Council file No. 09-2895), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the accompanying ORDINANCE dated June 1, 2011, adding Article 5.10 to Chapter IV of the Los Angeles Municipal Code to prohibit harassment of bicyclists because of their status as bicyclists by making it unlawful to intentionally force or attempt to force a bicyclist from a roadway for purposes unrelated to public safety, and by clarifying that a violator would be liable for an award of treble damages, attorneys' fees, and costs of litigation.
2. NOT PRESENT and ORDER FILED the Ordinance dated February 16, 2011, relative to prohibiting harassment of bicyclists, rendered moot by the adoption of the above Ordinance.
