COMMUNICATION FROM CHAIR, HOUSING, COMMUNITY AND ECONOMIC DEVELOPMENT COMMITTEE relative to authority to release a Request for Proposals for the Day Laborer Program.

Recommendations for Council action:

- 1. AUTHORIZE the Community Development Department (CDD) General Manager, or designee, to prepare a Request for Proposals (RFP) for the Day Laborer Program (DLP) to be effective April 1, 2011 and to release the RFP document subject to approval by the City Attorney as to form and legality.
- 2. DIRECT the CDD General Manager, or designee, subsequent to completing the DLP proposal evaluation process, to submit recommendations to the Mayor and City Council for DVSO contractor selection and funding for the 12 month period of April 1, 2011 through March 31, 2012.

Fiscal Impact Statement: The CDD reports that the recommendations do not impact the General Fund.

Community Impact Statement: None submitted.

SUMMARY

At a regular meeting held on October 27, 2010, the Housing, Community and Economic Development Committee considered authority to release a Request for Proposals for the Day Laborer Program. After an opportunity for public comment was held, the Committee recommended Council approve the recommendations contained in the CDD report. This matter is now forwarded to the Council for its consideration.
