
Council Rule 38 Referral

An ordinance amending Section 4.307 of the Los Angeles Administrative Code pertaining to health insurance for non-represented employees to add a new subsection (d) to provide for an Anthem Blue Cross Full-Network HMO option during the 2013 plan year.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Section 4.307 of the Los Angeles Administrative Code is amended by adding a new subsection (d) to read as follows:

(d) 2013 Plan Year – Anthem Blue Cross Full-Network HMO Option. Notwithstanding subsections (b) and (c) above, which pertain to monthly medical plan subsidies and employee premium costs for non-represented full-time and half-time employees, respectively, each employee who chooses the Anthem Blue Cross Full-Network HMO option for the 2013 plan year shall be required to pay the difference between the monthly subsidy paid by the City for the Anthem Blue Cross Select-Network HMO and the Anthem Blue Cross Full-Network premium for the coverage level selected, as calculated by the Personnel Department.

The employee premium costs provided under this subsection shall be in addition to any percentage of the healthcare premium paid by the employee in accordance with subsections (b) and (c) above.

Sec. 2. This ordinance shall be operative upon publication, pursuant to Charter Section 252(g).

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
