PLANNING AND LAND USE MANAGEMENT (PLUM) COMMITTEE REPORT relative to amending the Chapter IX of the Los Angeles Municipal Code (LAMC) for corrections to building regulations.

Recommendation for Council action:

REQUEST the City Attorney to prepare and present a final draft Ordinance amending various portions of all articles of Chapter IX of the LAMC to correct improper code section references, including code section references where missing, including metric measurements, and to make other changes to obtain consistency and correctness within Chapter IX of the LAMC.

Fiscal Impact Statement: None submitted by the Los Angeles Department of Building and Safety. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

At a regular meeting held on October 31, 2017, the PLUM Committee considered a proposed ordinance relative to amending the Chapter IX of the LAMC for corrections to building regulations. After an opportunity for public comment, the Committee recommended to approve on consent the proposed ordinance. This matter is now submitted to the Council for consideration.
