Recommendations for Council action:

1. NOTE and FILE the May 4, 2018 Department of Aging report and the May 18, 2018 Los Angeles Food Policy Council - Center for Good Food Purchasing.
2. INSTRUCT the Department of Aging, with assistance from the Los Angeles Food Policy Council - Center for Good Food Purchasing and the City Administrative Officer (CAO), to provide a response to the Budget and Finance Committee instructions approved in the Fiscal Year 2018-19 Budget.
3. INSTRUCT the CAO to review the previously submitted reports and the Department of Aging report responsive to the Budget and Finance Committee instructions, when transmitted, and provide recommendations on how the Department of Aging can remain in compliance with the Good Food Purchasing Policy while controlling meal costs.

Fiscal Impact Statement: None submitted by the Department of Aging. Neither the CAO nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.
