The City Council ADOPTED the following recommendation(s), contained in COMMUNICATIONS FROM THE MAYOR AND CITY ADMINISTRATIVE OFFICER which were WAIVED, pursuant to Council Rule 17, by the Chair of the Public Safety Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. AUTHORIZE the Mayor, or designee, to:
 - a. Modify the existing grant budget for the FY 2012 Grants to Encourage Arrest Policies and Enforcement of Protection Orders Program Grant Award by reallocating funds between agencies as described within the CAO report to the Mayor and Council dated February 21, 2014 (attached to the Council file).
 - b. Negotiate and execute, on behalf of the City, a contract with Valley Trauma Center, for Sexual Assault Response Teams (SART) services, for a term of up to 12 months within applicable grant performance period, in an amount not to exceed \$61,785, subject to the approval of the City Attorney as to form and legality.
 - c. Negotiate and execute, on behalf of the City, a contract with Peace Over Violence for SART services, for a term of up to 12 months within the applicable grant performance period, in an amount not to exceed \$61,785, subject to the approval of the City Attorney as to form and legality.
- 2. AUTHORIZE the Mayor, or designee, to prepare Controller's instructions for any necessary technical adjustments, subject to the approval of the CAO; and, AUTHORIZE the Controller to implement the instructions.
