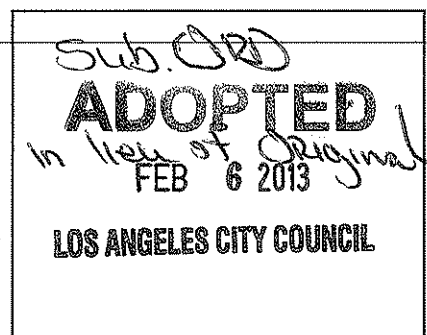


Council Action
