Recommendation

ITA has reviewed the CHMC Hope Street Family Center Property Management LLC (CHMC Hope Street) application for a private line telecommunications franchise and recommends approval of that application request as set forth below.

Background

A private line telecommunications facility is an encroachment permit that provides for the interconnection between two points in the public rights-of-way, utilized solely for signal transmission and not to serve any customer within the City. CHMC Hope Street is requesting that the City grants to CHMC Hope Street, a limited franchise to install and maintain a private line telecommunications facility which will encroach into portions of the public rights-of-way located on Venice Boulevard, just east of Hope Street.


Fiscal Impact

Fiscal impact is negligible. Approval and implementation of this private line telecommunications franchise will generate slightly more than \$9,000 in franchise fees over the next 10 years during the term of the franchise. In addition CHMC Hope Street is required to provide the City with a franchise performance bond in the amount of \$12,000.
