Council Action

The City Council ADOPTED the following recommendation(s), contained in a COMMUNICATION FROM CITY ADMINISTRATIVE OFFICER which were WAIVED, pursuant to Council Rule 17, by the Chair of the Transportation Committee:

1. AUTHORIZE the General Manager, Los Angeles Department of Transportation (LADOT) to execute an operating agreement with Metro Services Group for landscaping, maintenance, and repair services at 117 City-owned off-street parking facilities for a term of five years with the option of one additional three-year agreement at the sole discretion of the City, subject to the approval of the City Attorney as to form and legality, at a cost not to exceed \$750,000 per year, plus Consumer Price Index (CPI) adjustment, and total compensation not to exceed \$6.75 million for the life of the contract.
2. LIMIT the LADOT annual expenditures on the contract to \$650,000, adjusted annually for Consumer Price Index.


MOTION

Item #17 on today's Council agenda (C.F. 12-0638) relative to a contract with Metro Services Group for landscaping, maintenance, and repair services at City-owned off-street parking facilities, includes \$100,000 to accommodate the General Services Department (GSD) so that they are able to also use these services. Since the release of the report, GSD has stated that they anticipate the need for an additional \$60,000 in work from Metro Services Group. This increase requires that LADOT's contract with Metro Services Group must be increased from \$750,000 to \$810,000 per year, plus Consumer Price Index (CPI) adjustment, and total compensation not to exceed \$7.3 million for the life of the contract.

I THEREFORE MOVE that Item #17 on today's Council agenda (C.F. 12-0638) relative to a contract with Metro Services Group for landscaping, maintenance, and repair services at City-owned off-street parking facilities, BE AMENDED to adopt the following recommendations in lieu of recommendation #1 in the report:



AUTHORIZE the General Manager, Los Angeles Department of Transportation (LADOT) to execute an operating agreement with Metro Services Group for landscaping, maintenance, and repair services at 117 City-owned off-street parking facilities for a term of five years with the option of one additional three-year agreement at the sole discretion of the City, subject to the approval of the City Attorney as to form and legality, at a cost not to exceed \$810,000 per year, plus Consumer Price Index (CPI) adjustment, and total compensation not to exceed \$7.3 million for the life of the contract.


