The City Council ADOPTED the following recommendation(s), contained in a COMMUNICATIONS FROM THE CITY ADMINISTRATIVE OFFICER (CAO) and CITY ATTORNEY which were WAIVED, pursuant to Council Rule 17, by the Chair of the Personnel and Animal Welfare Committee (Item No. 25, Council file No. 12-1148), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT:
 - a. The accompanying ORDINANCE approved as to form and legality by the City Attorney amending Schedule A of Section 4.61 of the Los Angeles Administrative Code (LAAC) to implement the salary ranges and rates for non-represented employees as listed in Attachments A I and A II, and for non-represented General Managers as listed in Attachment B, to be operative July 1, 2012; January 1, 2013; and July 1, 2013 respectively.
 - b. The accompanying ORDINANCE approved as to form and legality by the City Attorney amending Schedule B of Section 4.900.1 of the LAAC to implement the salary ranges and rates for the Department of Water and Power non-represented employees to be operative July 1, 2012; January 1, 2013, and July 1, 2013, respectively.
 - c. The accompanying ORDINANCES approved as to form and legality by the City Attorney amending LAAC Sections 4.61 (Notes 3 and 4 applicable to the City Clerk Elections Division), 4.74(c), 4.120, 4.127.1, 4.129, 4.244(c), 4.307, 4.307.1 and 4.900.1 to provide for technical and housekeeping changes.
 - d. A policy providing for non-represented employees in commensurate classes to receive future salary adjustments adopted by the City Council for the Administrative and Supervisory Administrative bargaining units, represented by the Engineers and Architects Association.
2. AUTHORIZE the Controller and the CAO to correct any clerical errors, or if approved by the City Attorney, any technical errors in the above Ordinances.
