
Council Rule 38 Referral

An ordinance amending Subsection (c) of Section 4.244 of the Los Angeles Administrative Code to delete a reference to deductible absences that had been added to the definition of "Service Year" in error in Ordinance No. 181780.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection (c) of Section 4.244 of the Los Angeles Administrative Code is amended in its entirety to read as follows:

(c) **"Service year"** means each period of twelve (12) consecutive months and 2080 regular paid hours (non-overtime) of employment following an employee's entrance or re-entrance into service with the City including any of its departments, or between any two anniversaries of such entrance or re-entrance.

Sec. 2. This ordinance shall be operative upon publication, pursuant to Charter Section 252(g).

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
