PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to amending Section 42.00, Subsection (c), of the Los Angeles Municipal Code to remove the exception for sight-seeing tour operations from the prohibition of soliciting employment of services on the street.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Section 42.00, Subsection (c), of the Los Angeles Municipal Code to remove the exception for sight-seeing tour operations from the prohibition of soliciting employment of services on the street.

SUMMARY

At a regular meeting held on August 21, 2013, the Public Works and Gang Reduction Committee considered a City Attorney report and Ordinance relative to amending Section 42.00, Subsection (c), of the Los Angeles Municipal Code to remove the exception for sight-seeing tour operations from the prohibition of soliciting employment of services on the street. An opportunity for public comment was held. After a brief discussion, the Committee moved to approve the Ordinance. This matter is now forwarded to the Council for its consideration.
