

COMMUNICATION FROM CHAIR, PUBLIC SAFETY COMMITTEE relative to Juvenile Justice Crime Prevention Act (JJCPA) supplemental grant funding for the Los Angeles Police Department (LAPD) to continue implementation of the "high risk/high need" and "safe passages/safe zones" programs.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the Chief of Police, or designee, to:
  - a. Accept the 2012-13 supplemental JJCPA grant award in the amount of \$61,540 from the Los Angeles County Probation Department for the period July 1, 2012, to June 30, 2013.
  - b. Negotiate and execute an amended or new Memorandum of Agreement for Fiscal Year 2012-13 between the City of Los Angeles and the Los Angeles County Probation Department for the period July 1, 2012, through June 30, 2013, for a total of \$357,799, subject to the approval of the City Attorney as to form and legality.
2. AUTHORIZE LAPD to:
  - a. Submit grant reimbursement requests to the grantor and deposit the grant receipts in Police Department Grants Fund No. 339, Department 70.
  - b. Expend additional grants funds up to the supplemental grant amount of \$61,540 in accordance with the grant award agreement.
3. AUTHORIZE the Controller to:
  - a. Increase the grant receivable in Fund 339/70 by \$61,540.
  - b. Increase the appropriation in Fund 339/70, Account 70J202, 2013 JJCPA Grant by \$61,540.
  - c. Transfer funding up to \$61,540, on an as-needed basis, from Fund 339/70/70J202 to Police Department Fund No. 100/70, Account 1092, Overtime – Sworn.
4. AUTHORIZE LAPD to prepare Controller's instructions for any necessary technical adjustments consistent with this action, subject to the approval of the City Administrative Officer (CAO); and, REQUEST that the Controller implement the instructions.

Fiscal Impact Statement: The CAO reports that this action will not impact the General Fund. Approval of the above recommendations will provide \$61,540 for LAPD to fund juvenile delinquency prevention and intervention programs as part of the JJCPA grant program. No matching funds are

required. Acceptance of the grant and approval of the above recommendations are in compliance with City financial policies in that grant funds and budgeted funds will cover program costs.

Community Impact Statement: None submitted.

### SUMMARY

In a report to the Mayor and Council dated March 22, 2013 (attached to the Council file), the CAO states that LAPD requests authority to accept a JJCPA supplemental grant award in the amount of \$61,540. The CAO reports that JJCPA is administered by the Los Angeles County Probation Department to provide prevention and intervention programs for at-risk youth and their families who reside in recipient jurisdictional boundaries and attend school in identified school district service areas. The grant assists LAPD implement its high risk/high need and safe passages/safe zones programs that focus on curtailing juvenile delinquency through prevention and intervention services. The grant funds overtime for LAPD personnel, uniforms for program participants, and office equipment and supplies.

According to the CAO, the original grant award amount of \$357,799 was reduced to \$296,259 due to reduced funding availability. Subsequently, LAPD was notified that \$61,540 in funding would be restored as a supplemental grant. On January 29, 2013, the Board of Police Commissioners approved LAPD's request. The CAO concurs with this action.

At the special Public Safety Committee meeting held March 27, 2013, the Committee Chair recommended that Council authorize LAPD to accept the supplemental grant award and to approve the related actions above, as recommended by the Board of Police Commissioners and the CAO.
