PUBLIC SAFETY COMMITTEE REPORT relative to the 2013-14 Juvenile Justice Crime Prevention Act program grant award for use by the Los Angeles Police Department (LAPD).

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the Chief, LAPD, or designee, to:

- a. Accept the 2013-14 Juvenile Justice Crime Prevention Act grant award in the amount of \$393,579 from the Los Angeles County Probation Department for the period July 1, 2013 through June 30, 2014.
- b. Negotiate and execute the accompanying Memorandum of Understanding (MOU) for Fiscal Year (FY) 2013-14 between the City of Los Angeles and the Los Angeles County Probation Department for the period July 1, 2013 through June 30, 2014 for a total of \$393,579, subject to the approval of the City Attorney as to form and legality.

2. AUTHORIZE the LAPD to:

- a. Spend up to the total grant amount of \$393,579 in accordance with the MOU.
- b. Submit grant reimbursement requests to the grantor and deposit the grant receipts in the Police Department Grants Fund No. 339/70.

3. AUTHORIZE the Controller to:

- a. Establish a grant receivable in the amount of \$393,579 and establish an appropriation account, account number to be determined, within Fund No. 339/70 for the receipt and disbursement of 2013-14 Juvenile Justice Crime Prevention Act grant funds.
- b. Increase appropriations on an as-needed basis, as follows:

4. AUTHORIZE the LAPD to prepare Controller's instructions for any technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE the Controller to implement the instructions.

Fiscal Impact Statement: The CAO reports that this action will not impact the General Fund. Approval of the above recommendations will provide \$393,579 in funding to the LAPD for juvenile delinquency prevention and intervention programs on an overtime basis as part of the Juvenile Justice Crime Prevention Act grant program. No matching funds are required. Acceptance of the grant and approval of

the above recommendations are in compliance with City financial policies in that one-time funding is used for one-time expenses.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Mayor and Council dated November 4, 2013 (attached to the Council file), the CAO states that the LAPD requests retroactive approval to apply for and accept a \$393,579 grant award from the Los Angeles County Probation Department for the 2013-14 Juvenile Justice Crime Prevention Act program.


According to the CAO, the Juvenile Justice Crime Prevention Act grant is a state grant administered by the Los Angeles County Probation Department to provide prevention and intervention programs for at-risk youth and their families who reside in recipient jurisdictional boundaries and attend school in identified School District Service Areas. Grant funds are used by the LAPD to help implement High Risk/High Need and Safe Passages/Safe Zones programs that focus on curtailing juvenile delinquency through prevention and intervention services. The Safe Passages/Safe Zones program aims to allow students and their families to safely engage in daily activities including attending school and obtaining community services in or in close proximity to schools, parks, and housing projects that are designated Juvenile Justice Crime Prevention Act sites. As part of this program, LAPD provides enhanced patrol services, probation check-ins to offer assistance and community partner service referrals, monitoring gang activity and violations, and conducting truancy and curfew sweeps. Additionally, area youth participate in LAPD's Cadet Program. Grant funds will be used for LAPD personnel overtime, uniforms for Cadet Program participants, and office equipment and supplies.

On October 8, 2013, the Board of Police Commissioners approved LAPD's request for authority to apply for and accept the Justice Crime Prevention Act grant. The CAO concurs with this action.

At its meeting held November 8, 2013, the Public Safety Committee recommended that Council authorize LAPD to accept this grant, as recommended by the Board of Police Commissioners and the CAO.
