PUBLIC SAFETY COMMITTEE REPORT relative to supplemental grant funding for use by the City Attorney to develop an anti-tobacco prevention campaign for students in the Los Angeles Unified School District (LAUSD).

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the City Attorney, or designee, to amend the grant award for the Tobacco Industry Manipulation Exposed (TIME) Project by \$32,778, from \$39,230 to \$72,008 for the grant performance period July 1, 2012 to June 30, 2016.
2. APPROVE and AUTHORIZE the City Attorney, or designee, to execute the sub-allocation grant award amendment for the TIME Project agreement between the City and the LAUSD for the period of July 1, 2012 to June 30, 2016, subject to the approval of the City Attorney as to form and legality.
3. AUTHORIZE the City Attorney, or designee, to accept the amended grant award in the amount of \$72,008 for the TIME Project for the period July 1, 2012 to June 30, 2016.
4. AUTHORIZE the Controller to establish:
 - a. A receivable within Fund 368 in the amount of \$32,778.
 - b. The following appropriation account:

Account 12J641 FY 12-13 TIME \$32,778
5. TRANSFER up to \$31,753 from Fund 368/12, Account 12J641 to Fund 100/12, Account 5301, Reimbursement from Other Funds/Depts upon receipt of reimbursement.
6. AUTHORIZE the City Attorney to prepare Controller instructions for any necessary technical adjustments consistent with this action and subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE the Controller to implement the instructions.

Fiscal Impact Statement: The CAO reports that the total cost of the TIME Project is \$72,008, which consists of \$39,230 in previously accepted grant funding and \$32,778 in supplemental grant funding. Funding is provided by the LAUSD for salaries, related costs, and expenses. There is no additional General Fund impact. The acceptance of the use of the grants is consistent with City financial policies in that budgeted appropriations will be balanced against receipts expected from the continuation of the grant.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Mayor and Council dated December 20, 2013 (attached to the Council file), the CAO states that the City Attorney requests authority to accept supplemental grant funding in the amount of \$32,778 from the LAUSD for the anti-tobacco prevention campaign TIME Project. LAUSD received grant funds from the California Department of Education and awards funds to the City as a sub-grantee. The supplemental grant funding also extends the grant performance period end date to June 30, 2016. The City Attorney will use grant funds to provide assistance in the development of an anti-tobacco youth prevention campaign for LAUSD students, which includes raising awareness on illegal tobacco sales to

minors and point of purchase policies. The grant will fund two positions in the City Attorney's Tobacco Enforcement Program and operating supplies to be used in trainings. The CAO recommends approval of the City Attorney's request.

At its meeting held January 24, 2014, the Public Safety Committee recommended that Council approve the award of supplemental grant funds to the City Attorney, as discussed above, and as recommended by the CAO.
