Recommendation for Council action:

At a meeting held on February 13, 2013, the Chair of the Housing, Community and Economic Development Committee considered a Communication from the Mayor dated September 19, 2012 relative to the appointment of Reverend Dr. Clyde Oden, Jr. to the Los Angeles Homeless Services Authority Commission, and a subsequent Communication from the Mayor dated January 11, 2013 relative to a request by Reverend Oden to withdraw from further consideration for appointment.
