**RECOMMENDATION**

That the Board **APPROVE** the Executive Director's report and **RECOMMEND** the City Council approve the transfer of ownership interest in Archer's Vineland Service, Inc., Official Police Garage for Service Area 15, Contract No. C-107059, to Navarro's Towing North Hollywood, LLC.

**DISCUSSION**

Los Angeles Municipal Code Section 80.77.4 (e) (2) states that any sale or transfer of a majority of either the ownership interests or stock, except public share stocks, of any official police garage shall be subject to the approval of the City Council, which shall consider any recommendation made by the Board of Police Commissioners.

On April 18, 2012 Archer's Vineland Service Inc. requested approval of the City of Los Angeles to sell its interest to Heriberto Eddie Navarro doing business as Navarro's Towing. Commission Investigation Division has completed a background investigation of Navarro's Towing and recommends approval of the transfer of ownership. The background investigation is available for review by contacting the Executive Director of the Police Commission.
