COMMUNICATION FROM CHAIR, HEALTH, EDUCATION, AND NEIGHBORHOOD COUNCILS COMMITTEE relative to the Neighborhood Council Subdivision Elections.

Recommendation for Council action:

AUTHORIZE the City Clerk to reallocate up to \$128,000 in funds appropriated for Neighborhood Council Elections build out/set up (related to Council File No. 15-1022-S2, Recommendation No. 7) toward the conduct of up to three Neighborhood Council subdivision elections from funds allocated in Fiscal Year 2017-18.

Fiscal Impact Statement: The City Clerk reports that this action will have no impact to the General Fund as previously allocated funds will be used.

Community Impact Statement: None submitted.

Summary:

At a regular meeting held on February 27, 2018, the Health, Education, and Neighborhood Councils Committee considered the February 22, 2018 City Clerk report relative to the 2018 Neighborhood Council Subdivision Elections. The City Clerk provided some background on the matter and responded to questions from the Committee Chair. After an opportunity for public comment, the Committee Chair amended the instructions to combine the two recommendations in the February 22, 2018 City Clerk reports into one recommendation as reflected above.
