INFORMATION TECHNOLOGY AND GENERAL SERVICES COMMITTEE REPORT relative to a non-financial transfer of jurisdiction of the City-owned property located at 1490 West Torrance Boulevard, Los Angeles, CA 90501 from the Department of General Services (GSD) to the Department of Recreation and Parks (DRP).

Recommendations for Council action, pursuant to Motion (Buscaino - Perry):

1. INSTRUCT the GSD to effectuate a non-financial transfer of jurisdiction of the City-owned property located at 1490 West Torrance Boulevard, Los Angeles, CA 90501, Assessor Parcel No. 7351025900 to the DRP.
2. REQUEST that the Board of Recreation and Parks consider, approve, and accept the transfer of jurisdiction of the above-referenced City-owned property, and dedicate it as park property in perpetuity.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On January 8, 2013, your Committee considered Motion (Buscaino - Perry) relative to a non-financial transfer of jurisdiction of the City-owned property located at 1490 West Torrance Boulevard, Los Angeles, CA 90501 from the GSD to the DRP. The Motion, attached to the Council file, provides background information on this issue. During the discussion of this item, Councilmember Buscaino provided an overview of the Motion and recommended approval. After providing an opportunity for public comment, the Committee recommended that Council approve the recommendations contained in the Motion, as reflected above.
