Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE extending to March 31, 2015, the expiration date applicable to the Southern California Gas Company Franchise Ordinance No. 168164.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

Accompanying a report to Council dated November 5, 2014, the City Attorney presents Ordinance extending the expiration date applicable to the Southern California Gas Company Franchise. In 1992, the City granted for a term of 20 years a franchise authority to the Southern California Gas Company to install, construct, replace, reconstruct, repair, and retain its gas system in streets located in the City of Los Angeles; maintain and operate said gas system; and, engage in the business of the transmission and distribution of gas to customers within the City of Los Angeles. The franchise term has been extended a number of times, the current extension expires December 31, 2014.

At its special meeting held November 12, 2014, the Transportation Committee recommended that Council approve the accompanying Ordinance.
