g. Up to \$180,000 from Fund 54H, Department 46, Account 46J170 to Fund 100, Department 70, Revenue Source Code 5161, to reimburse the LAPD for direct salary costs.

h. Up to \$28,639.92 from Fund 54H, Department 46, Account 46J299 to Fund 100, Department 46, Revenue Source Code 5346, for reimbursement of grant-funded fringe benefits for the Mayor's Office.

- i. Cash from Fund 53E, Department 46 and Fund 54H, Department 46, to reimburse the General Fund on an as-needed basis, upon presentation of proper documentation from the Emergency Management Department (EMD), Los Angeles Fire Department (LAFD), Los Angeles Housing Department (LAHD), and LAPD, subject to the approval of the Mayor's Office of Homeland Security and Public Safety approval.
2. AUTHORIZE the Mayor, or designee, to prepare Controller's instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, REQUEST that the Controller implement the instructions.

Fiscal Impact Statement: The CAO reports that this action will not impact the General Fund. Approval of the above recommendations will allow for the continued expenditures of FY 2009 and 2010 RCPP grant awards. The above recommendations are in compliance with City financial policies in that budgeted appropriations will be balanced against receipts expected from this grant.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Mayor and Council dated February 21, 2013 (attached to the Council file), the CAO states that the Mayor requests authority to re-appropriate funds for the FY 2009 and 2010 RCPP grant awards from the California Emergency Management Agency. The CAO reports that \$564,983.23 of the FY 2009 RCPP grant award, and \$748,640.92 for the FY 2010 RCPP grant award is available for re-appropriation. For the FY 2009 RCPP, the Mayor requests that funds be transferred for LAFD, LAHD, LAPD and the Mayor's Office to appropriate funds in the current fiscal year within the grant fund. Funds also will be transferred for EMD to reallocate cost savings from Partner Jurisdictions and various EMD training classes to support EMD staff salaries in the current fiscal year. For 2010 RCPP, the Mayor requests authority to re-appropriate funds for the EMD, LAFD, LAPD, and Mayor's Office to appropriate funds in the current fiscal year within the grant fund. The CAO recommends approval of the Mayor's request. At the Public Safety Committee meeting held February 22, 2013, Committee Members recommended that Council approve the CAO's recommendations relative to this matter.
