TRANSPORTATION COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to authorizing Los Angeles Department of Transportation (LADOT) employees to obtain federal, state, and local summary criminal history information.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Section 71.01.2 of Chapter VII of the Los Angeles Municipal Code (LAMC) to authorize LADOT employees to obtain federal, state, and local summary criminal history information pursuant to California Penal Code Sections 11105(b)(11) and 13300(b)(11), in fulfilling their duties applicable to Chapter VII and Chapter VIII of the LAMC.


Community Impact Statement: None submitted.
