HOUSING COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to redesignating the Los Angeles Housing Department as the Housing and Community Investment Department (HCID) and transferring the administration of human services programs and commissions from the Community Development Department (CDD) to the HCID.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending amending Section 22.600 of Article 1, Chapter 24, Division 22 of the Los Angeles Administrative Code (LAAC) to re-designate the Los Angeles Housing Department as the Housing and Community Investment Department (HCID), amending various provisions of the LAAC and Los Angeles Municipal Code to conform therewith, and amending certain other provisions of the LAAC to transfer administration of human service programs and commissions from the CDD to the HCID.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At a regular meeting held on August 28, 2013, the Housing Committee considered a report from the City Attorney, and Ordinance, dated July 17, 2013 relative to amending the Los Angeles Administrative and Municipal Codes to re-designate the Los Angeles Housing Department as the Housing and Community Investment Department (HCID), and to transfer administration of human services programs and commissions from the Community Development Department to the HCID.

The Executive Officer of the HCID appeared before the Committee to provide a brief status report on the integration of the HCID and components of the former CDD, and responded to related questions. After providing an opportunity for public comment, the Committee recommended that Council approve the recommendations in the City Attorney report and adopt the accompanying Ordinance. This matter is now forwarded to the Council for its consideration.
