~~COMMUNICATION FROM CHAIR, HOUSING, COMMUNITY AND ECONOMIC DEVELOPMENT COMMITTEE~~ relative to authorization to submit the 2014-15 Community Services Block Grant (CSBG) Community Action Plan to the State of California Department of Community Services and Development.

Recommendation for Council action:

AUTHORIZE the General Manager, Community Development Department (CDD), or designee, to sign and submit the 2014-15 Community Action Plan for the CSBG to the State of California Department of Community Services and Development on behalf of the City by June 27, 2013, subject to the review of the City Attorney as to form and legality.

Fiscal Impact Statement: The City Administrative Officer (CAO) reports that there is no additional General Fund impact. The 2013-14 Adopted Budget approved approximately \$1.5 million for administrative costs: \$1.2 million for direct costs and \$0.3 million for indirect costs to be funded by the CSBG. The recommended action in this report is in compliance with the City's Financial Policies in that the services in the Community Action Plan for CSBG will be fully funded by federal grant funds.


Community Impact Statement: None submitted.

SUMMARY

At a regular meeting held on June 5, 2013, the Chair of the Housing, Community and Economic Development Committee considered a transmittal from the CDD dated May 15, 2013, and a report from the CAO dated June 4, 2013, relative to authorization for the CDD to submit the 2014-15 CSBG Community Action Plan to the State of California Department of Community Services and Development on behalf of the City.

After providing an opportunity for public comment, the Committee Chair recommended that Council approve the recommendation in the CAO report. This matter is now forwarded to the Council for its consideration.
