## Council Action

The City Council ADOPTED the following recommendation(s) relative to an application for determination of Public Convenience or Necessity for alcohol sales for off-site consumption at Yucca Supermarket grocery store:

1. DETERMINE that the issuance of a liquor license at Yucca Supermarket grocery store located at 1815 North Cahuenga Boulevard, Los Angeles, 90028, will serve the Public Convenience or Necessity and will not tend to create a law enforcement problem.
2. GRANT the Application for Determination of Public Convenience or Necessity for the sale of alcoholic beverages for off-site consumption at 1815 North Cahuenga Boulevard.
3. INSTRUCT the City Clerk to transmit this determination to the State Department of Alcoholic Beverage Control as the required findings under Business and Professions Code Section 23958.4.

**MOTION**

**I MOVE** that the matter of CONTINUED CONSIDERATION OF HEARING COMMENTS relative to application for determination of Public Convenience or Necessity for alcohol sales for of-site consumption at Yucca Supermarket grocery store, Item 2 on today's Council Agenda (CF 13-0671), BE AMENDED to ADOPT the following ADDITIONAL RECOMMENDATIONS:

1. The sale of beer or malt beverages in quantities of quarts, 22 oz., 32 oz., 40 oz., or similar size containers are prohibited. No beer, malt beverages or wine coolers shall be sold in quantities less than six per sale.
2. Distilled spirits may not be sold in containers smaller than 750ml.
3. From opening hours to closing hours, every two hours an employee must inspect the parking lot and adjacent areas of the business for loiterers. A log must be kept on the premises documenting the employees name, date and time he/she inspected the required area.
4. Petitioner(s) shall install and maintain security cameras and a three month video library that covers all common area of the business, high-risk areas and entrances or exits. The videotapes shall be made available to the Los Angeles Police Department upon request.
