

COMMUNICATION FROM MEMBERS, TRANSPORTATION COMMITTEE relative to prohibiting the parking of oversize vehicles in Westchester area streets.

Recommendation for Council action, as initiated by Resolution (Bonin - Cedillo):

1. RESOLVE, pursuant to Los Angeles Municipal Code Section 80.69.4, to authorize the Los Angeles Department of Transportation (LADOT) to install signs prohibiting the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height between 2:00 a.m. and 6:00 a.m. for the following street segments located in the Westchester community: Hindry Place between Arbor Vitae Street and Hindry Avenue, Glasgow Place between 93rd Street and Hindry Avenue, 99th Place between Isis and Hindry Avenues, 99th Street between Isis and Hindry Avenues, 98th Street between Aviation Boulevard and Hindry Avenue, 97th Street between Atwell Place and Hindry Avenue, Atwell Place between 98th and 97th Streets, 96th Street between Aviation Boulevard and Glasgow Place, 93rd Street between Aviation Boulevard and Glasgow Place, Isis Avenue between Arbor Vitae Street and 99th Place, and Aviation Boulevard between 93rd and 98th Streets.
2. DIRECT the LADOT to post signs giving notice of "no parking, 2:00 a.m. to 6:00 a.m.; vehicles over 7 feet high or 22 feet long except by permit" restriction for oversize vehicles, on the above streets.

Fiscal Impact Statement: None submitted. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted

### SUMMARY

On November 20, 2013, Council considered Resolution (Bonin – Cedillo) relative to prohibiting the parking of oversize vehicles in Westchester area streets. Large vehicles are being left parked for long periods of time on Westchester area streets, instead of being properly stored on the owners' properties or in appropriate off-street storage facilities, limiting parking availability for the businesses and blocking traffic. Resolution makers recommend that Council authorize "no parking, 2:00 a.m. to 6:00 a.m.; vehicles over 7 feet high or 22 feet long except by permit" restrictions on the impacted streets. Council referred Resolution to the Transportation Committee for consideration.

At the Transportation Committee meeting held December 11, 2013, Committee members recommended that Council approve the recommended actions of Resolution(Bonin – Cedillo).
