

First Amendment to Contract Number C-132720
Between the City of Los Angeles and
Chatsworth B.I.D., Inc.

This First Amendment to Contract Number C-132720 ("AGREEMENT") is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("CITY") and CHATSWORTH B.I.D., Inc., a California nonprofit mutual benefit corporation ("CORPORATION"), with reference to the following:

WHEREAS, CITY and CORPORATION have entered into an AGREEMENT for the performance of services related to providing administration of the Chatsworth Business Improvement District ("DISTRICT"); and

WHEREAS, the term of the AGREEMENT expired May 31, 2019 and the CITY and the CORPORATION agree to continue their contractual relationship through December 31, 2019 to allow the CORPORATION to expend roll-over funds to pay for expenses incurred during the original contract term for Contract No. C-132720;

NOW, THEREFORE, CITY and CORPORATION agree that the AGREEMENT be amended effective June 1, 2019 as follows:

AMENDMENT

1. Section 1, TERM OF AGREEMENT, shall be amended in its entirety as follows:
 - 1.1. The term of this AGREEMENT will commence on the date of attestation by the CITY CLERK, and will, unless otherwise terminated as set forth herein, end on December 31, 2019. Said term is subject to the provisions herein.
2. Section 2, CORPORATION RESPONSIBILITIES, shall be amended in its entirety as follows:
 - 2.1. CORPORATION shall be responsible for expending roll-over funds totaling \$79,961.60 to pay for expenses incurred during the original contract term of June 1, 2018 through May 31, 2019, for the development, implementation, direction, and operation of the District's programs, improvements, and activities. CORPORATION shall not incur any new or additional expenses related the District's programs, improvements, and activities.
3. Except as herein amended, all other provisions and conditions of Contract Number C-132720 shall remain in full force and effect.
