The "Hollywood Mobility Trust Fund" portion of the Council District 13 Public Benefits Trust Fund provides funding for community benefits designed to improve the quality of life and foster a variety of mobility options for Hollywood residents.

Civic Enterprises Associates, LLC is providing specialized services to develop parking management strategies including proposals to develop modified parking districts in Hollywood.

This effort is of special benefit for the residents of the City and for CD-13 and deserves financial assistance from the City.

Sufficient funds are available in the "Hollywood Mobility Trust Fund" portion of the Council District 13 Public Benefits Trust Fund for this purpose.

I THEREFORE MOVE that \$88,860 in the "Hollywood Mobility Trust Fund" account in the Council District 13 Public Benefits Trust Fund No. 904 be appropriated /allocated / utilized / spent for specialized services by Civic Enterprises Associates, LLC, to develop parking management strategies including proposals to develop modified parking districts in Hollywood.

I FURTHER MOVE that the City Clerk be directed to prepare and process the necessary document(s) and/or agreement(s) with Civic Enterprises Associates, LLC, or any other agency or organization, as appropriate, in the above amount, for the above purpose, subject to the approval of the City Attorney as to form, if needed, and that the Councilmember of the District be authorized to execute any such documents on behalf of the City.

I FURTHER MOVE that the Council FIND that the services to be performed by Civic Enterprises Associates, LLC are for the performance of professional, scientific, expert, technical, or other special services of a temporary and occasional character for which competitive bidding is not practicable or advantageous and that the work can be performed more economically or feasibly by independent contractors than by City employees.

I FURTHER MOVE that the City Clerk be authorized to make any corrections or clarifications to the above fund transfer instructions in order to effectuate the intent of this Motion.
