PUBLIC SAFETY COMMITTEE REPORT relative to two Supplemental Police Account (SPA) reports.

Recommendation for Council action:

APPROVE two Los Angeles Police Department (LAPD) SPA reports (attached to the Council file) to the Board of Police Commissioners: the report dated November 22, 2013, for the period April through June, 2013; and, the report dated November 27, 2013, for the period July through September, 2013.

Fiscal Impact Statement: None submitted by the LAPD. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

In two reports to the Board of Police Commissioners dated November 22, 2013, and November 27, 2013, respectively, LAPD summarizes SPA activity for the periods April through June, 2013, and July through September, 2013. For the second quarter of 2013, there were 20 Account expenditures in which drugs or assets were seized. These expenditures resulted in 33 arrests and the seizure of \$145,919.00 in United States currency. Also seized were 118,028.90 grams of narcotics with a street value of \$3,265,951.09.

For the third quarter of 2013, LAPD reports that there were 19 Account expenditures in which drugs or assets were seized. These expenditures resulted in 28 arrests and the seizure of \$432,763.00 in United States currency. Also seized were 3,708.96 grams of narcotics with a street value of \$ 244,968.86. On December 10, 2013, the Board approved LAPD's reports.

At its meeting held January 24, 2014, the Public Safety Committee recommended that Council approve LAPD's SPA reports for the second and third quarters of 2013.
