PUBLIC WORKS PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT relative to the proposed first amendments to 17 contracts for on-call architectural services in order to complete design and related work on various active municipal facilities and recreation and park facility projects.

Recommendation for Council action:

AUTHORIZE the Board of Public Works to execute the proposed first amendments, to extend the term by five years, retroactively from July 8, 2013 through July 8, 2018, substantially in form to the attached boilerplate amendment agreement, between the Bureau of Engineering and the following 17 on-call architectural consulting firms:
