Veranda Way, North Seaglass Circle, East Seaglass Circle, South Seaglass Circle, West Seaglass Circle, Sparrow Court, Seahorse Court, Lantern Court, Heron Way, Hammock Lane and Discovery Creek Place – Private Driveways Name Establishment between Dawn Creek and McConnell Avenue and also Runway Road and Bluff Creek Drive.

RECOMMENDATIONS:

- A. That the name of the private driveways between Dawn Creek and McConnell Avenue and also Runway Road and Bluff Creek Drive, shown on Exhibit "A", be established as Veranda Way, North Seaglass Circle, East Seaglass Circle, South Seaglass Circle, West Seaglass Circle, Sparrow Court, Seahorse Court, Lantern Court, Heron Way, Hammock Lane and Discovery Creek Place (Private Driveway).
- B. That the Council, find that the name establishment is exempt from the California Environmental Quality Act of 1970, pursuant to Article III, Class 5(4) of the City's Environmental Guidelines.
- C. That the City Clerk be instructed to transmit the following:

DISCUSSION:

Request: The petitioner, Candace Ginn, is requesting the City to establish the name of the private driveways lying between Dawn Creek and McConnell Avenue and also Runway Road and Bluff Creek Drive, as shown on Exhibit "A", as Veranda Way, North Seaglass Circle, East Seaglass Circle, South Seaglass Circle, West Seaglass Circle, Sparrow Court, Seahorse Court, Lantern Court, Heron Way, Hammock Lane and Discovery Creek Place.

The petitioner is requesting the name establishment for the private driveways on Lots 9 to 17, Tract No. 60110, in order to provide names to the approved circulation system created for the surrounding single family detached condominium project located on the above referenced lots.

The naming of the private driveways does not signify that they are either a public street or approved private street and is for identification purposes only.

Upon adoption of the Report by the City Council, the adjoining property owners and concerned agencies will be notified of the name establishment.
